1. Class C GSUs entitle the Reporting Person to receive one share of Alphabet Inc. Class C capital stock for each share underlying the GСУ as GСУ vests. 1/14th of the grant vests on the 25th day of each month 10 months after the grant date and an additional 1/14th will vest monthly on the 25th day of each month thereafter, subject to continued employment on each vesting date.
2. 1/18th of the grant will vest on the 25th day of the month starting on March 25, 2025; 1/36th of the grant will vest on the 25th day of each month starting on March 25, 2026; and 1/36th of the grant will vest on March 1, 2027, subject to continued employment on each vesting date.
